



## CONGRATULATIONS TO THE 2011-2012 RISK MANAGEMENT GRANT RECIPIENTS

Each year VMLIP provides Risk Management Grant funding to members for the purchase of vital equipment and training to strengthen risk management programs which may otherwise be cost prohibitive.

This year VMLIP has awarded **93 members** with **\$177,000** in Risk Management Grant funding, reserving an additional \$23,000 for recipients of 2011 Risk Management Awards. Reimbursements were based on criteria such as program coverage, premium level, Risk Management Guidelines assessment needs, as well as submission date and availability of funding.

Funds were exhausted in 89 days from its start on July 1, 2011, a new record set this year.

Risk management programs, and support of those efforts, are a critical part of effectively managing a governmental entity, and the following entities are to be commended for their risk management awareness.
